### **6. AREA REPORTS**

JS Chair, Kathy Morris Admin, James Oliver Treasurer, Mark Hewson membership officer, Adam R General member.

Recent motion at NAGM to abolish upper age limit has helped Lincs Quest.

MD – Has the FB ad attracted anyone and cost? JS £100 per group, had enquiries but not collated yet. To do at publicity action day. Facebook traffic has increased. Will need to determine how to classify and process PNMs in collaboration with the FB group owners. SR – Lincs Q. numbers seem to have dropped. JS – Covid affected. Also they had kept to the 65 age limit. But it is starting to go in the right direction now (maybe 60% of them were over 65)

At the Hoburne site St. Mabyn, Just over £100 pp. MD – when are we publicising the Cornwall hol? AB only 5 chalets left, let AB know if interested. SR thanked AB and BA for the Hoburne weekend. AB said mostly Ben's work!

BA walked us through Hoburne monies and chalet allocations. Wants to make Hoburne the last weekend of April for the next several years. Makes it 3 months after WASH. AB what about late Easters? BA – There are no late Easters in the medium term. BA will aim to get a private / quiet area booked for the quiz.

CB written report. IC commended it. CB building contacts starting with Area Chairs. He liked the Stevenage publicity. BA said Nessa Nash started from scratch for Stevenage PRO and has made a flying start without prior help.

CB wants to set up a central email address + FB page to link to other groups. JS – Mark Hewson could help set up a centralised address. IC worried a link to links on FB would be too static, thus falls down search engine rankings. JS – there are Plus pages that have this already. CB – Yes we can use the existing pages. Action for JS to give access to CB for his FB pages. Also – Action SR to contact MH to contact CB re: centralised email address. SR why did you like the Stevenage page. CB – Vibrant, colourful, bright, enticing. Shows they are friendly and doing a lot of varied activities and it seems to work.
